

## Montague Markets - 'Totally Yours, Tote Bag Giveaway' Terms & Conditions

- Customers who spend a minimum of \$40 or more at any participating specialty store or combination of specialty stores at Montague Markets are eligible to receive a FREE Tote Bag. Contact and spending details must be provided via the QR code or collection form and Receipts must be presented. One (1) FREE tote bag per person over the promotional period.
- 2. Receipts exclude Woolworths, prescription or scheduled medication, tobacco or tobacco-related products and lotto and gambling purchases.
- 3. The promotion period is from Saturday 13 July Saturday 20 July.
- The tote bag giveaway promotion will run ONLY on the following dates: Wednesday 17 July 2.30pm 6.30pm, Thursday 18 July 2.30pm - 6.30pm, Friday 19 July 9.00am - 1.00pm, Saturday 20 July 9.00am - 1.00pm OR while stocks last.
- 5. Total quantity of Montague Market branded Tote Bags is 500.
- 6. To claim FREE Tote Bag original receipt/s from specialty stores must be presented for sighting by the promotional ambassador.
- To verify gift has been collected customers must complete the collection form by completing the online form via QR scan code or via collection form.
- 8. Receipts must be dated within the promotional period from Saturday 13 July Saturday 20 July. Original receipts only, no scanned copies or photocopies.
- 9. Customers must be 18 years or over to redeem.
- 10. The FREE tote bag will need to be collected from the in-Centre booth during the promotional times and dates stated above.
- 11. The following persons are not eligible to utilise the promotion
  - Tenants of Montague Markets
  - Employees of tenants of Montague Markets
  - Contractors of Montague Markets and their employees
  - Immediate family members of any of the above i.e. spouses and children
