

## Montague Markets - 'Dine and Wine' Terms & Conditions

- Customers who spend a minimum of \$60 or more at any Montague Markets retailer, excluding Woolworths, are eligible to receive a FREE Bottle of Pre-Selected Wine from BWS Montague Markets. Contact and spending details must be provided via the QR code or collection form and Receipts must be presented. One (1) FREE Wine Bottle per person over the promotional period or until sold out. Whichever occurs first.
- 2. Customers MUST be 18 years or over to redeem. ID will be requested from BWS Montague Markets on collection.
- 3. The promotion period is from Wednesday 21 August Wednesday 11 September (the campaign has been EXTENDED while stock is available).
- 4. Offer Excludes Woolworths.
- 5. The pre-selected Wine includes Forester Estate Lifestyle Rose and Forester Estate Lifestyle Cabernet Merlot. The customer's preference is available until sold out.
- 6. The total quantity of Wine bottles is 200.
- 7. To claim a FREE Wine Bottle, original receipt/s from retailers must be presented/handed over for sighting by the BWS Montague Markets Team.
- 8. To verify the Wine Bottle has been collected customers must complete the collection form by completing the online form via QR scan code or via collection form.
- 9. Original receipts only, no scanned copies or photocopies.
- 10. The Wine Bottle/s will need to be collected from BWS Montague Markets during the promotional times and dates stated above.
- 11. The following persons are not eligible to utilise the promotion
  - Tenants of Montague Markets
  - Employees of tenants of Montague Markets
  - Contractors of Montague Markets and their employees
  - Immediate family members of any of the above i.e. spouses and children
- 11. The participants of the promotion agree to have their names used for advertising purposes.
- 12. All entry forms remain the property of the promoter at all times. In lodging an entry, all entrants consent to their names being entered into a database and accept that maintaining their anonymity is not practicable in the circumstances.
- 13. The promotion is promoted by Montague Markets, Corner Montague & Ferry Roads, West End, QLD 4101.
- 14. The promoter expressly disclaims any responsibility or liability whatsoever for injury or loss to any person or property relating to the delivery and/or subsequent use of the prize awarded.

For the purposes of compliance with applicable Privacy Legislation, entrants are advised that: they can contact the promoter for details of the information held about them at the address of the promoter stated above; the purpose for which the information on them is being collected is for marketing purposes related to the promotion of Montague Markets and its retailers; the information on them is not usually disclosed to third party organisations; failure to provide all the information required to make a valid entry **will** result in their entries being ineligible to collect their Wine Bottle.
